# Acceptable Usage Agreement

---

While I have access to the Computer Network and laptops/tablets and Internet at the Murri School:  
As a student:

I will **NOT**:

1. Cyber-Bully - access, impersonate, post, submit, publish or display harmful matter that is threatening, obscene, disruptive or sexually explicit, or that could be construed as harassment or disparagement of others based on their race, national origin, sex, sexual orientation, age, disability, religion or political beliefs.
2. Fill in questionnaires or other interactive forms on the internet without permission
3. Attempt to repair hardware or unplug cables or equipment
4. Reset computers/peripherals or change preferences
5. Knowingly infringe copyright
6. Carelessly or deliberately waste resources (all printing must be approved by teacher)
7. Vandalise - intentional uploading, downloading with a malicious intent
8. Read other users' files or attempt to delete, copy, modify or forge other users' network and account settings
9. Record audio or video without teacher's permission

I **WILL** always:

1. Report cyber bullies to teachers, family support workers, Deputy Principal, Principal or anonymously at the office
2. Keep passwords safe and not share them with other people
3. Follow safe internet practices by not disclosing personal information
4. Close an internet browser in the event of discovering inappropriate internet content and inform the teacher
5. Sign out and log off once finished with a computer/terminal/laptop/tablet

I have read the Computer Use and Internet Access Policy and Rules for Using Computers and school other devices whether onsite at the Murri School or offsite and agree to abide by the rules and responsibilities set out therein. I am aware that computer, laptop and tablet use aswell as internet access is provided to me for educational purposes ONLY. My use of school computers/laptop/tablet and internet will be electronically monitored and I will be held responsible for any misuse or damage of computer/laptop/tablet hardware/software or inappropriate material downloaded from the internet or stored on any computer/laptop/tablet occurring under my student logon. I accept that by logging onto the school's computer/laptop/tablet network, I am responsible for the keystrokes and mouse operation carried out on that computer. I understand that if the school decides I have broken these rules, appropriate action will be taken. This may include loss of access to the internet or computers or school issued laptops and tablets.

## **PARENT OR GUARDIAN**

I understand that the internet can provide students with valuable learning experiences. I also understand that it gives access to information on computers around the world; that the school cannot control what is on those computers; and that part of that information can be illegal, inappropriate, dangerous or offensive.

I accept that, while teachers will always exercise their duty of care, protection against exposure to harmful information must depend finally upon responsible use by students. I am aware that my son/daughter's use of the school computers, laptops tablets and the internet is electronically monitored and that he/she will be held responsible for any misuse or damage of computer/laptop/tablet hardware/software or any inappropriate material downloaded from the internet or stored on any computer or school device under his/her student logon as outlined above.

I believe my child understands this responsibility and I hereby give permission for him/her to access the school network and the internet under the school rules. I understand that students breaking these rules will be subject to appropriate action by the school. This may include loss of computer/laptop/tablet and/or internet access. I accept the contents and the intent of the Computer/School Device Use and Internet Access Policy and Agreement and I agree to support the school in enforcing this Policy.
